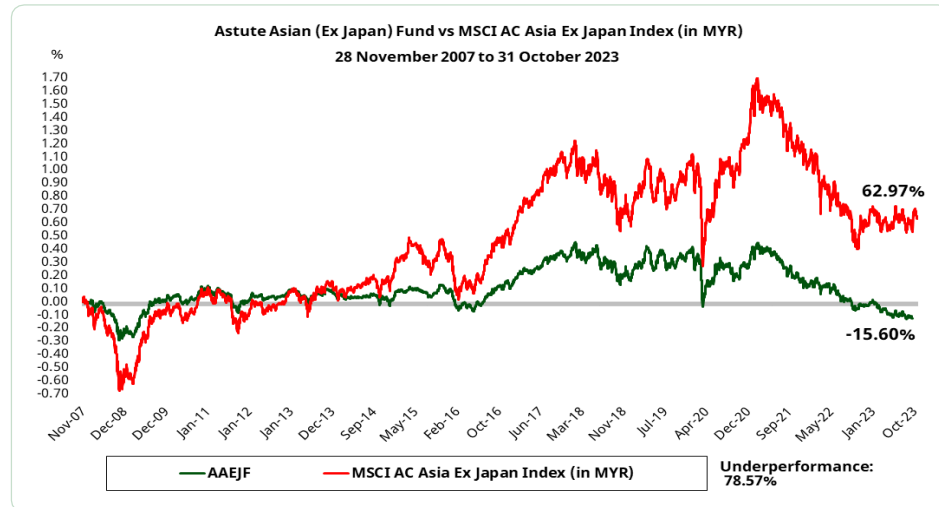


OBJECTIVE

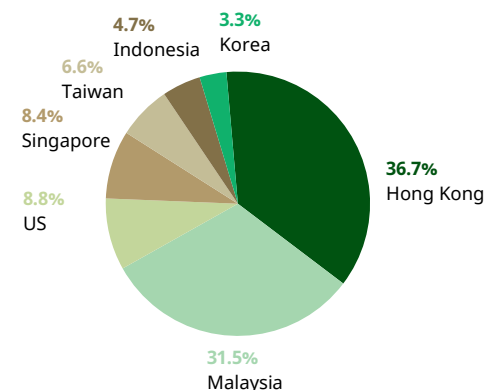
