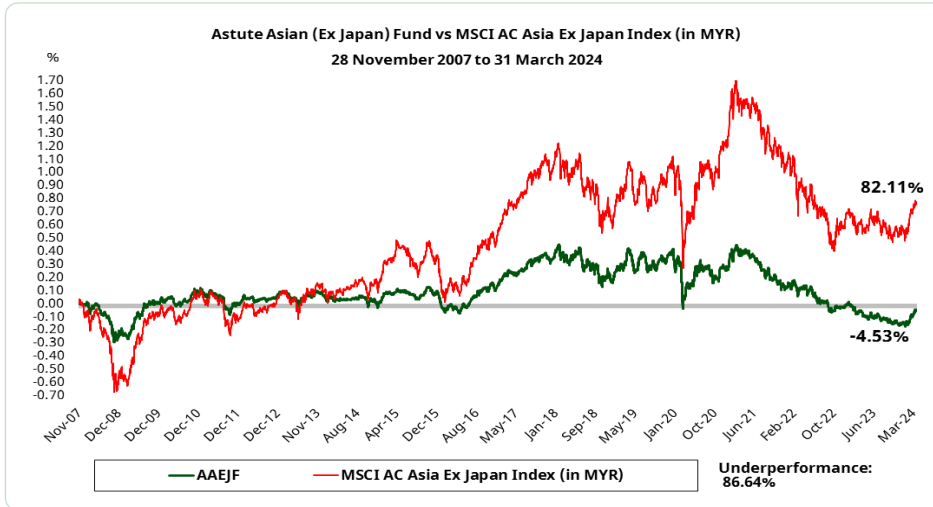


**OBJECTIVE**

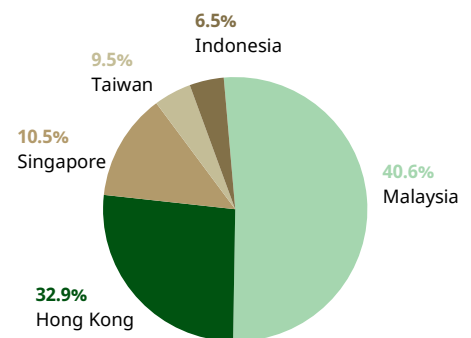
