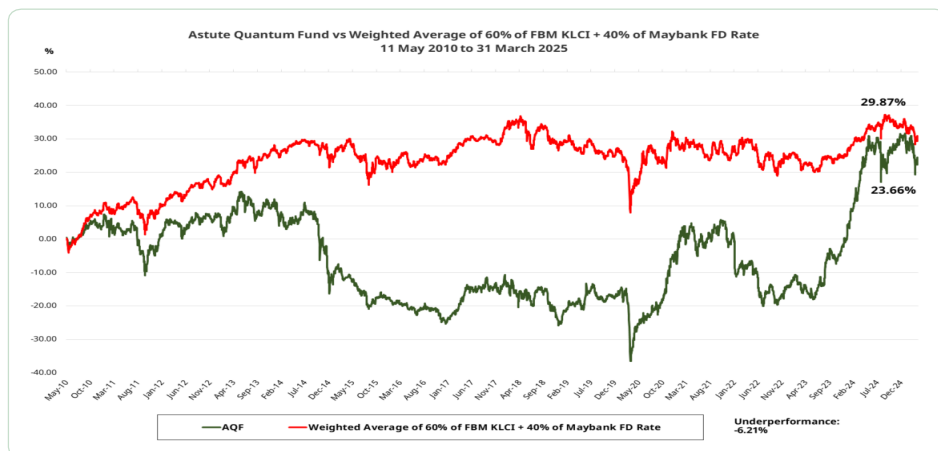


OBJECTIVE

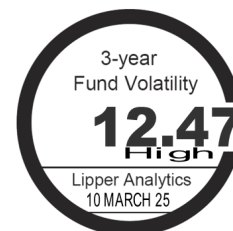
