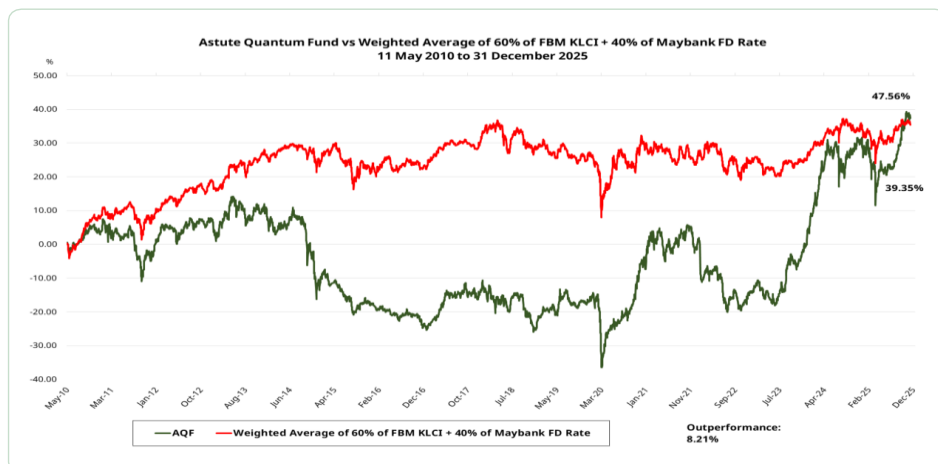


OBJECTIVE

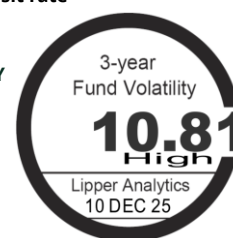
