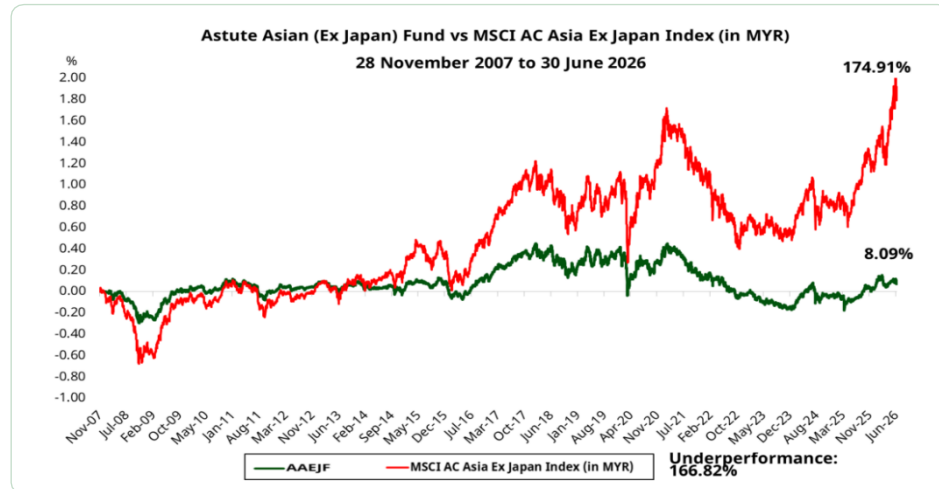


OBJECTIVE

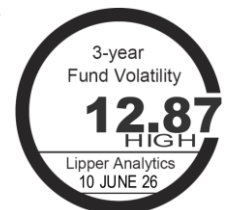

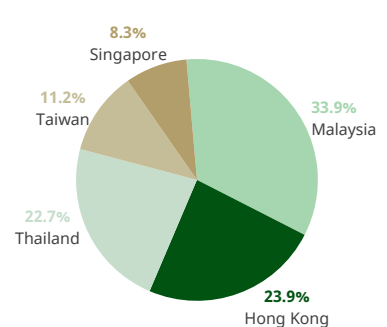
