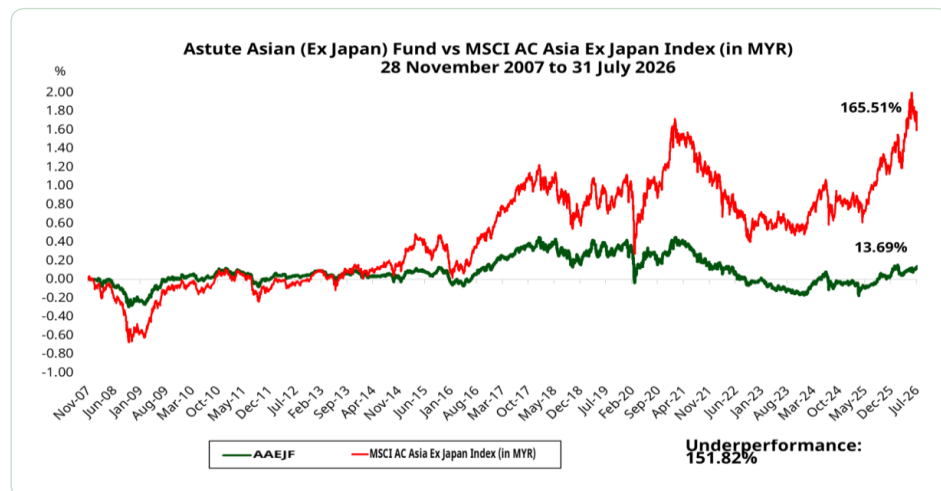


OBJECTIVE

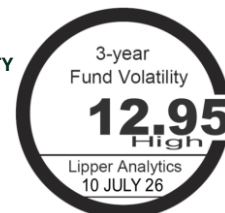

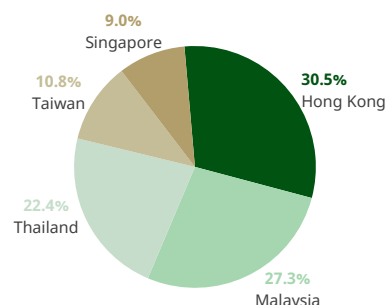
