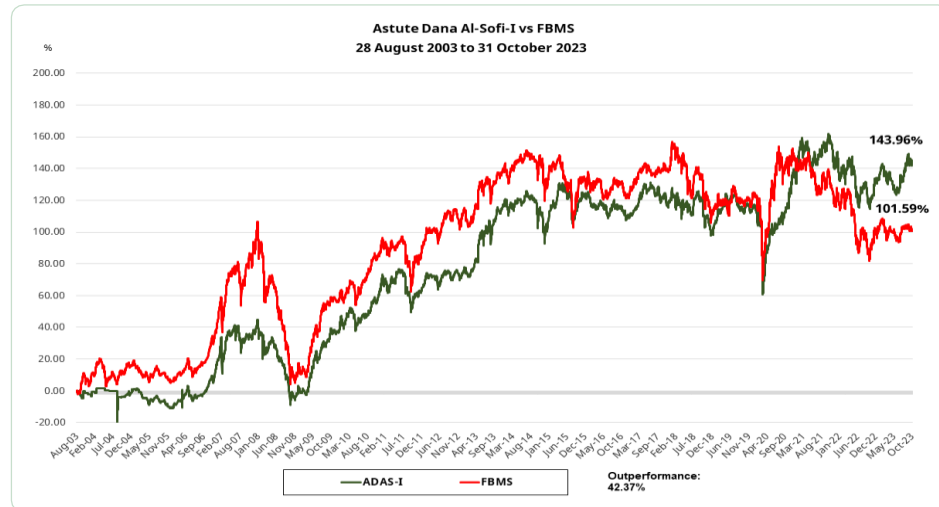


## OBJECTIVE
