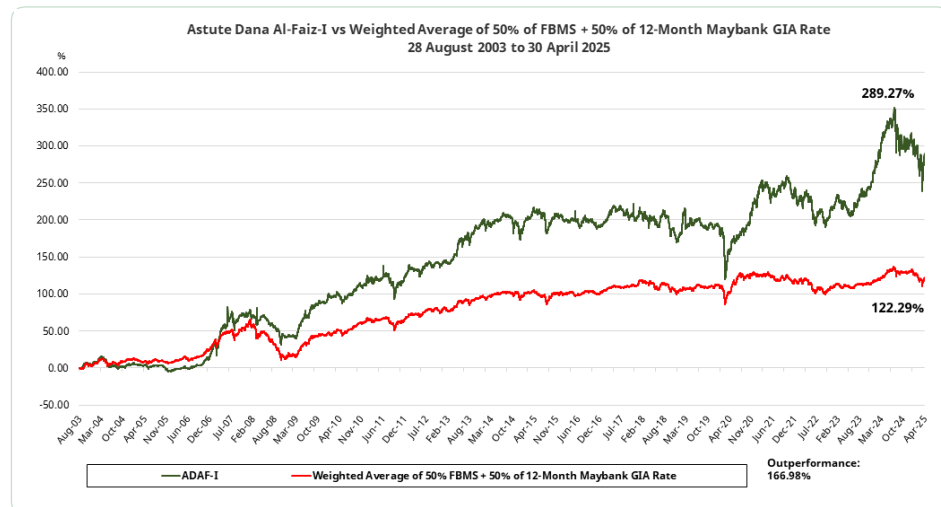


## OBJECTIVE

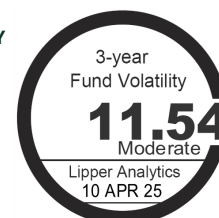
