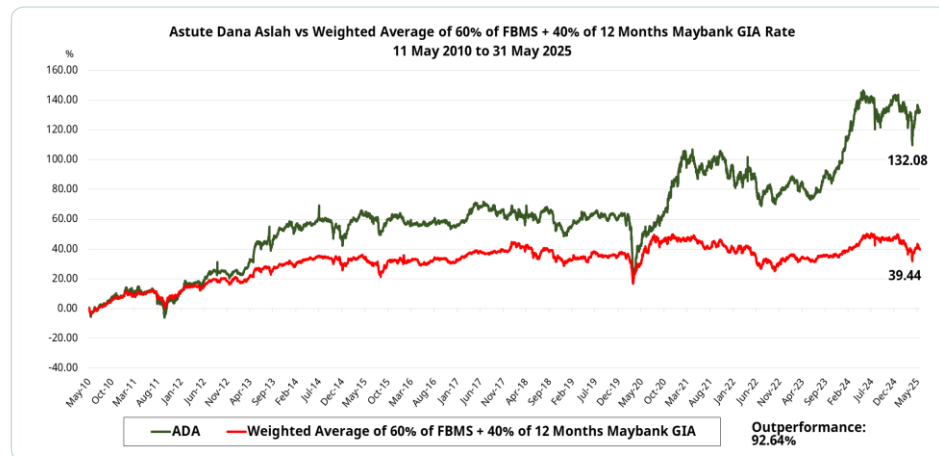


OBJECTIVE
