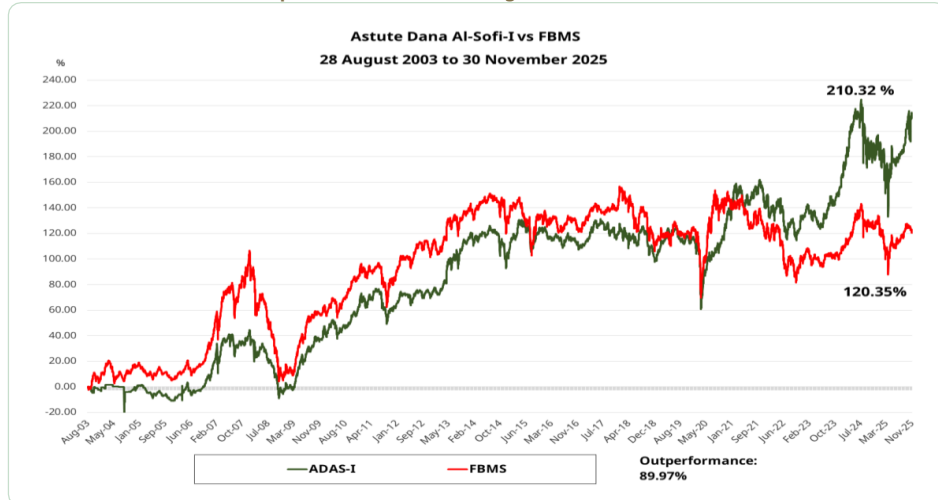


## OBJECTIVE
