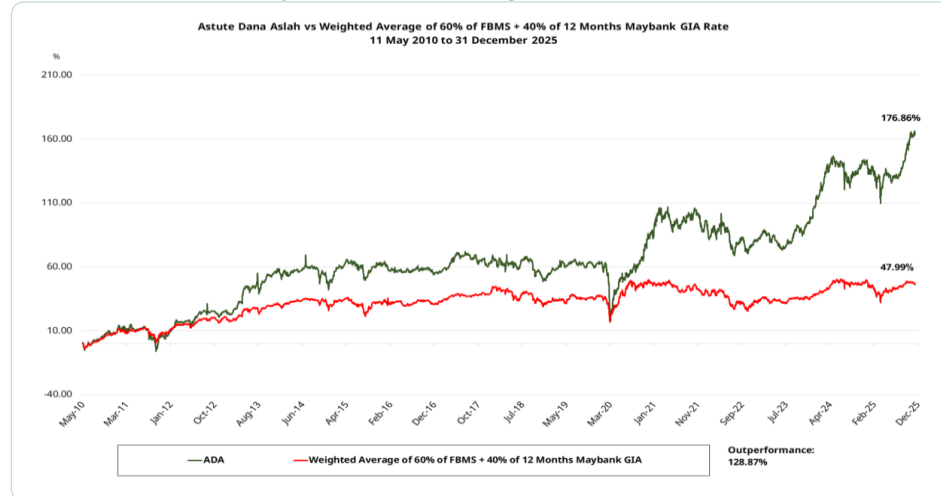


OBJECTIVE

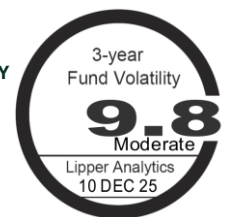
