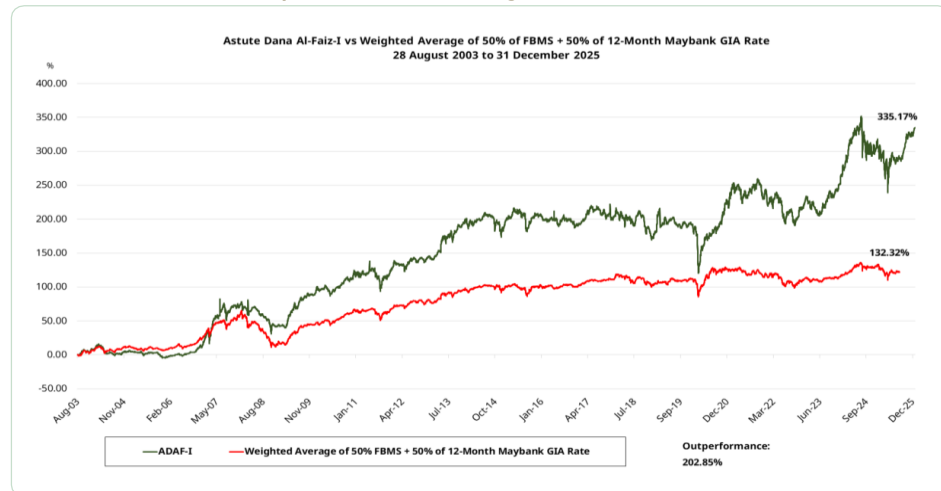


## OBJECTIVE
