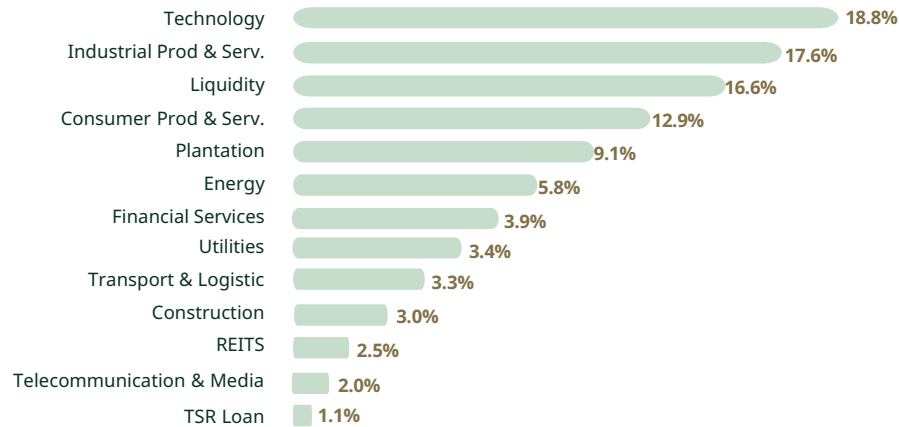

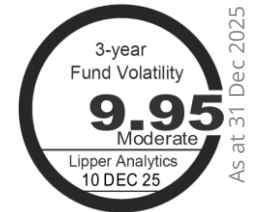
Disclosure Statements: Based on the Fund's portfolio returns as at 10 December 2025, the Volatility Factor (VF) for this Fund is 9.95 and is classified as 'Moderate' (source: Lipper). 'Moderate' includes funds with VF that are above 7.805 but not more than 10.405. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC. A copy of the Master Prospectus dated 17 August 2023 and the Product Highlights Sheet ("PHS") have been registered and lodged with the SC. Potential Investors

Investor who seek capital appreciation with regular distribution, have medium to high risk tolerance, and wish to invest in accordance to the Shariah principle.

Investment Strategy

To invest in a portfolio of sukuk and Shariah-compliant equity securities. The Fund will normally have an exposure of 60% in Shariah-compliant equity and Shariah-compliant equity-related securities and 35% in sukuk or Trustee Stocks. A minimum of 40% of its NAV is invested in Shariah-compliant equity and Shariah-compliant equity-related securities.

The asset allocation of the Fund for cash and Shariah-compliant equities will depend on the outlook of the market, whereby the exposure of the fund in Shariah-compliant equity and Shariah-compliant equity-related securities shall not be more than 95% of the Fund's NAV. The minimum level of the Islamic liquid assets to be held by the Fund at all times shall not be less than 5% of the Fund's NAV.

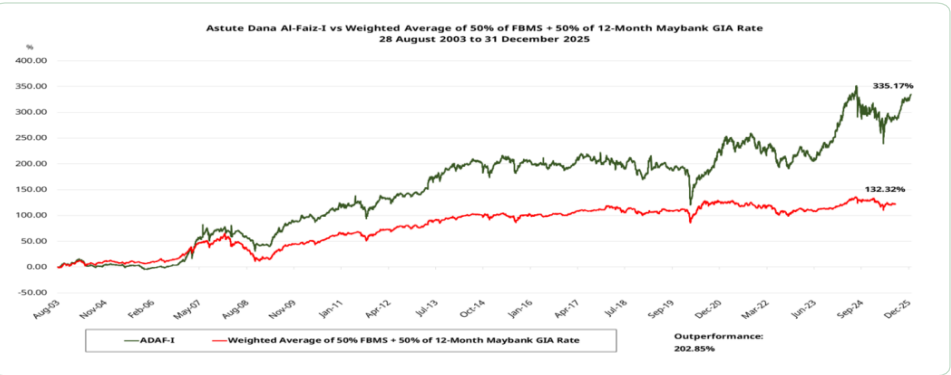
