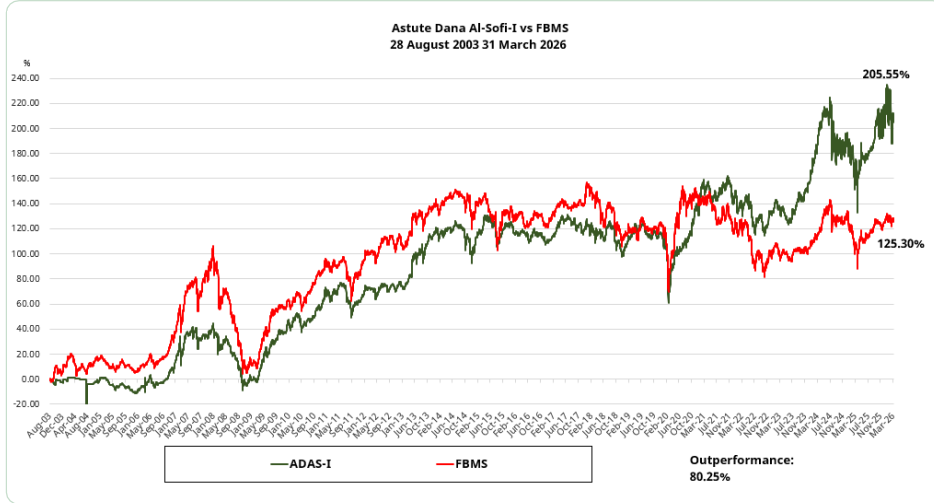


OBJECTIVE
