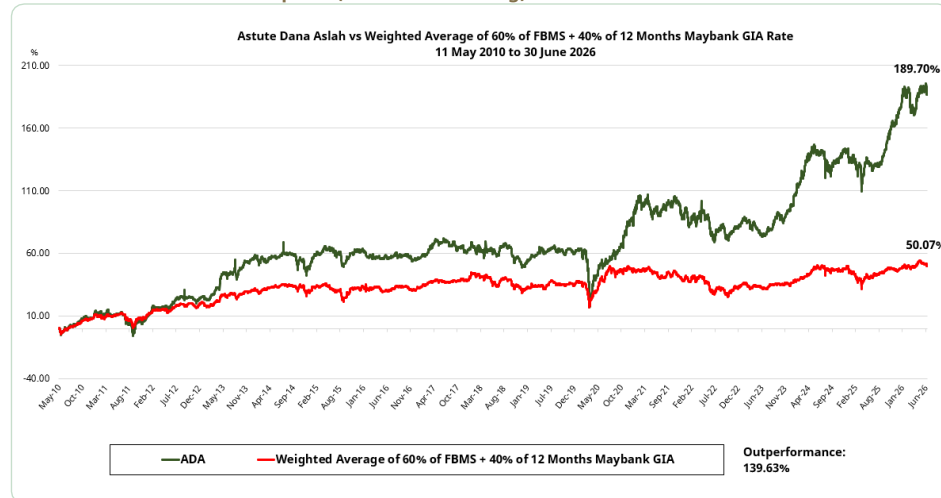


OBJECTIVE

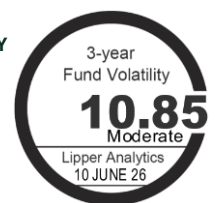
