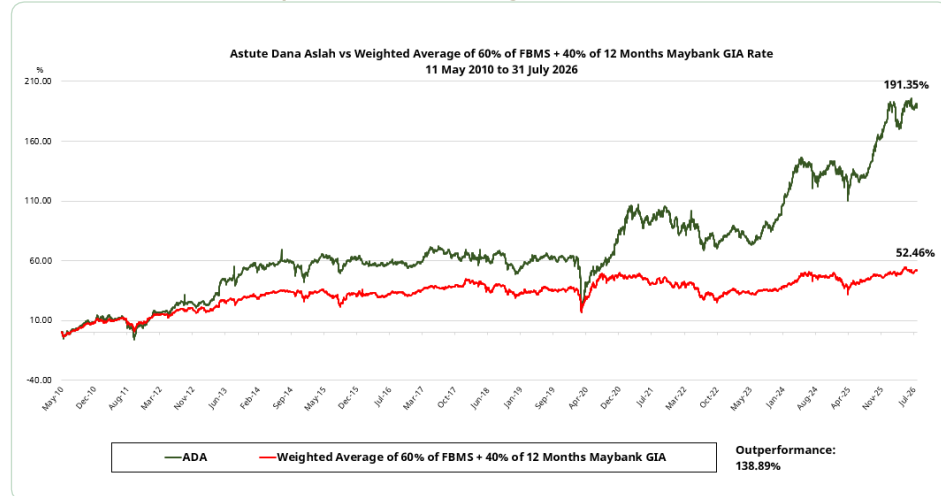


OBJECTIVE
