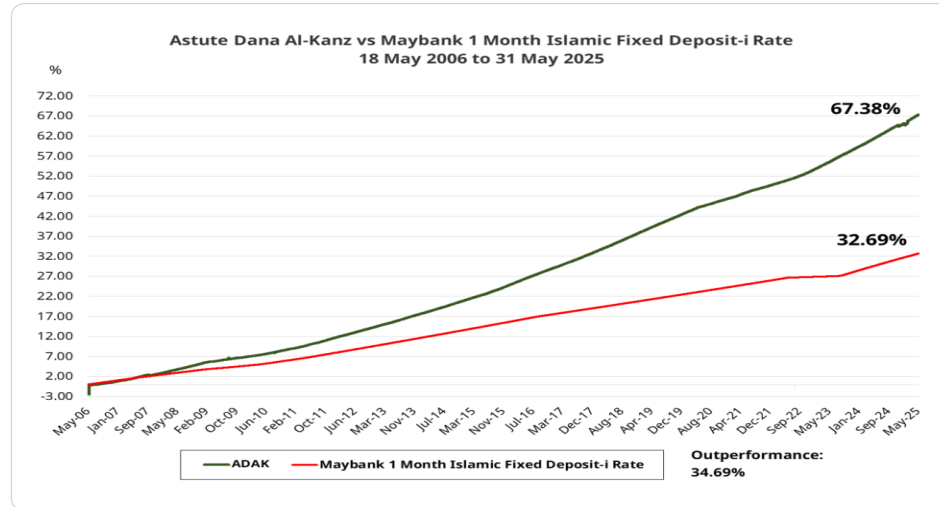


## OBJECTIVE
