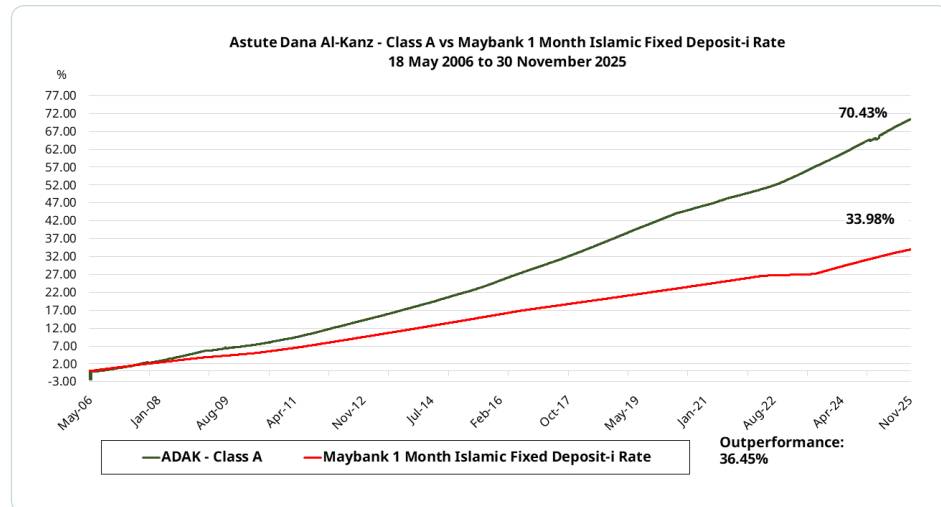


## OBJECTIVE

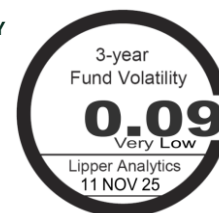
