

Disclosure Statements: Based on the Fund's portfolio returns as at 10 December 2025, the Volatility Factor (VF) for this Fund is 0.09 and is classified as 'Very Low' (source: Lipper). 'Very Low' includes funds with VF that are above 0 but not more than 4.195. The VF means there is a possibility for the Fund to generate an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC. A copy of the Master Prospectus dated 17 August 2023 and the Product Highlights Sheet ("PHS") have been registered and lodged with the SC. 
Investment Strategy

The Fund may at its absolute discretion, invests up to a maximum of 95% of its NAV in Islamic money market instruments and sukuk with maturity period of not more than 365 days. The Fund will also invest up to 10% of its NAV in sukuk with maturity period of not more than 732 days. The Fund will maintain a minimum of 5% of its NAV in Islamic liquid assets at all times.
