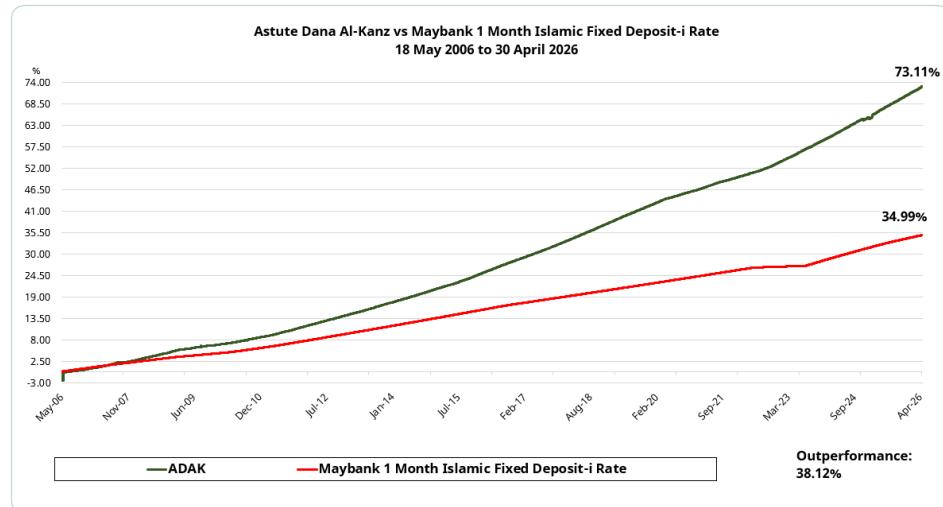


OBJECTIVE

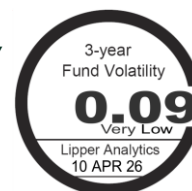

Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
