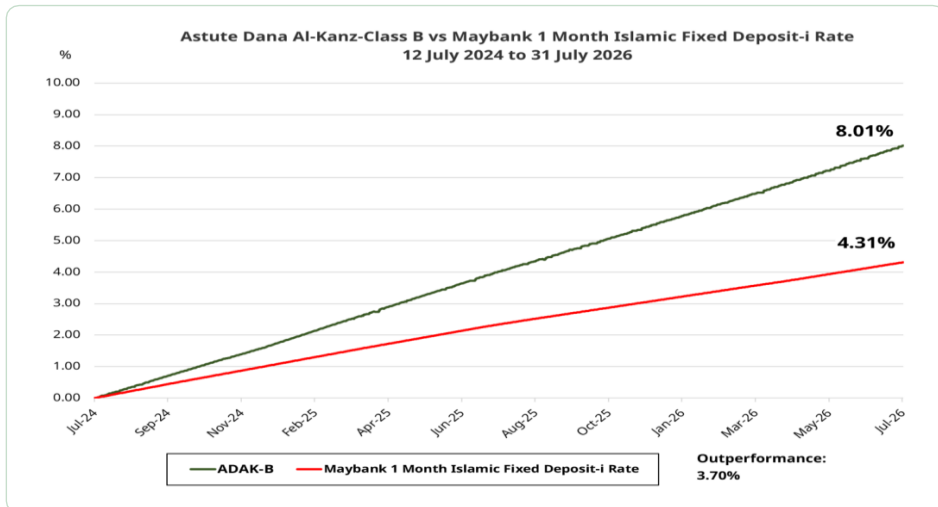


OBJECTIVE
